OFFICIAL RULES AND REGULATIONS

Eligibility

- A. Anyone 16 year of age or older are eligible.
- B. Entries will be accepted until 6:00 am day of the Tournament.
Fee \$150

Requirements

- A. Each contestant must have a valid WI Fishing License
- B. Waupaca Bass Club is not held responsible for death, injury, damage, liability, theft, fire, or loss.
- C. Each contestant is required to abide by all state boating and fishing laws.
- D. All contestants must attend rules meeting 6:00 am morning of the Tournament.

Weigh-In

- A. Prizes will be determined on total weight of 6 walleye per team (big fish will break ties)
- B. All Fish Must Be Alive! No Stringer Fish Will Be Weighed!

Fishing

- A. Only walleye will be allowed. **There is a 15-inch minimum size limit for this tournament.**
- B. Only fish caught on the same day of the Tournament 6:30-2:30 will be allowed.
- C. Contestants are not allowed to have anyone hold or save spots for them.
- D. All persons in competition boats must be entered in Tournament (2 people only)
- E. Contestants may not leave his/her boat during tournament hours except at official pit stops explained at meeting.
- F. Contestants are to fish in original boat in which they started. In case of break down, notify Tournament Director to make a change.
- G. General courtesy and good sportsmanship should be always shown.

Boundaries/Other Rules

- A. Fremont Bridge, near Bridge Bar to the HWY M Bridge in Hortonville
- B. No Alcoholic Beverage During Tournament
- C. Any Citations issued by Sherriff or DNR result in Disqualification
